As a member of the Greater Midwest Chapter, we encourage your participation in the effort to help select a new charity for a two-year term. We also encourage the GMC PCMA member recommending the chosen charity to play somewhat of an active role with the Community Services Committee.

## **Selection Procedures:**

- GMC-PCMA Member(s) to recommend a charity by forwarding the completed detailed questionnaire and collecting all reference materials.
- The Charity Selection Sub-Committee will review all recommendations in mid-August and will narrow down the top finalists. The finalists will then be notified to set up a time to give a short presentation of the charity.
- The entire Community Services Committee will meet following the presentation to select the top choice to be recommended to the GMC PCMA Board of Directors.
- The final decision will be made by the GMC PCMA Board of Directors.
- The 2018-2019 Charity will be announced at the Chapter Leadership Day & Awards Luncheon in January 2018.

## **Selection Criteria:**

- The Charity is located within the greater Chicagoland area.
- Opportunities exist for volunteers to relate directly to participant.
- The Charity has been established for a minimum of 5 years.
- Joint Public Relations opportunities are available by supporting the charity.
- Administrative costs do not exceed 25% of the charity's total budget.
